# Introduction

In the spirit of continuous improvement and community engagement, Danny's Ride conducts roughly quarterly surveys of our riders to gather insights into the impact of our programs, identify areas for improvement, and better advocate for continued funding and collaboration.

Danny's Ride is dedicated to providing transportation for individuals in recovery with nowhere or no one else to turn to. Through these surveys, we sought feedback on the effectiveness of our services, the satisfaction levels of our riders, and potential areas where we can innovate and expand.

This report presents the survey results, highlighting community needs, rider experiences, and quotes taken from riders with their permission. We extend our sincere gratitude to all participants who took the time to share their thoughts and experiences. Your feedback is invaluable in guiding our mission to make a positive and lasting impact.

### Method

Danny's Ride partnered with the Lehigh Valley Justice Institute, a 501(c)(3) nonprofit organization dedicated to data-driven research on social justice issues, to create, distribute, manage, and compile the survey results.

Through EZ Texting, we sent text messages to all riders who received service between April 1, 2024, and November 30, 2024, containing one of three surveys based on the institution through which they received their rides. One survey went to all riders who received service through the Treatment Court in Chester County, PA and Northampton County, PA. Another went to riders who received service through Pro-A, an organization that helps people in reentry and recovery obtain employment. All the other riders received the General Survey. All surveys were conducted in SurveyMonkey. Participants had the option to enter a drawing to win a \$25 digital Target gift card.

We sent each survey in two waves that were two weeks apart. After the first wave, we removed bounced phone numbers and phone numbers that had already responded to the first wave. Altogether, the response rate was 8.6%. Table 1 contains a summary of the surveys and how they were distributed.

### Questions

Appendix A contains the questions in each survey. Some questions allowed for multiple responses, such as the Race and Ethnicity, Awareness, Ride Purpose, and Transit Alternative questions. Except for the Race and Ethnicity question, response frequencies were based on all checked responses, not all respondents. Due to the large number of possibilities, the Race and Ethnicity chart is the only chart in this report that only contains the given responses, not all possible answer combinations.

Experience questions asked participants to rate their satisfaction on a scale of 1 to 5, with 1 being the lowest and 5 being the highest. Not all survey questions are included in this report.

Some prompts were open-ended. We coded these responses manually into categories determined by the responses. Each response could have satisfied several categories.

Danny's Ride monitors the true number of rides taken by each rider and the purpose of each ride. We included these true statistics along with the results from the surveys to allow for comparison between who did and did not respond to the survey. The true statistics are in the charts with the striped bars titled "Number of Rides from All Riders" on page 7 and "Ride purpose from all Riders" on page 8.

#### Cleaning


Manual sparse cleaning occurred for misspellings and when a write-in response matched other options provided. For example, if a participant wrote in "Levittown, PA" for the question "What state do you live in?" that response was recoded as Bucks County, Pennsylvania.






#### Danny's Ride made getting and keeping a job easier

#### How long have you had the job?




#### Do you have a job now?

# **Discussion and Conclusion**

The survey results are testimony to the mission and impact of Danny's Ride. The organization's main purpose is to provide free transportation to help individuals access appointments and services vital to the success of their recovery, and the outcomes show that Danny's Ride continues to achieve this goal. The top four location types that respondents traveled to were related outpatient services, medical appointments, medication assisted treatment (MAT), and support group meetings. Danny's Ride understands the importance of stability in recovery, and provided rides to legal meetings, employment, job interviews, and housing. Based on the true statistics, a greater share of riders from Treatment Courts used 30 or more rides than riders from the General survey, potentially indicating where individuals with higher needs may be located.

The overwhelming majority (88%) gave their experience with Danny's Ride a 4 or 5 out of a maximum of 5. Similarly, 96% of respondents responded with 4s or 5s when asked how much Danny's Ride helped them. Respondents expanded on this with open-ended answers and specific questions in the two specialized surveys. Unsurprisingly, most replies discussed how Danny's Ride aided their recovery by providing transportation to treatment, therapy, interviews, and jobs. Riders were also able to avoid interacting with individuals who may not have been a good influence on their sobriety and were able to attend required legal meetings and appointments. This helped them avoid legal fees, program extensions, and even incarceration. Participants reported being able to spend the money saved on transit for other necessary expenses. Five out of six Pro-A respondents said that Danny's Ride greatly helped them get or keep a job, and they all had a transit plan for work; this demonstrates independence now that they're back on their feet, thanks to a handful of free rides when they needed them most.

It was quite interesting that, for the prompt, "Please describe how Danny's Ride helped you," around 10% of respondents mentioned a personal touch or feeling forged by Danny's Ride. Some replies mentioned courteous and professional drivers, meeting new people, and connecting with others, while some were as simple and powerful as, "Greatly." Essentially, these connections were more powerful than any of the other tangible benefits of Danny's Ride. That speaks volumes about the impact of support – even a small lift can be an incredible gift to people experiencing such physical, mental, financial, and emotional hardship.

Twenty individuals had suggestions for improvement. Among those, two-thirds mentioned increasing the number of rides a person can receive or expanding the program to include rides to other services – another testament to Danny's Ride's usefulness. Interestingly, several individuals suggested better advertising, noting that the first time they heard or saw the words "Danny's Ride" was in the survey. While the survey represents a fraction of Danny's Ride riders, it may be worth reexamining advertising or branding strategies.

The resounding message is that recipients of Danny's Ride services were not only satisfied, but also immensely grateful. Appreciation radiated from the lists of THANK YOU's, so grateful's, blessing's, and more in the comments. It is clear that Danny's Ride is more than successful at helping individuals through their recovery. For many riders, Danny's Ride was and continues to be a beacon of hope when all the odds were stacked against them. It's more than just providing rides – they help people reclaim their lives.
